Enquiry regarding fishing and sealing restrictions in the vicinity of and on the islands of Prince Edward, Marion, Crozets, Hog, Heard and Gough.

PREVIOUS PAPERS

MINUTES

The Crozet Islands (which include Hog) are not British territory (see file 5/19). So far as I can find they are unclaimed by any country being very inaccessible, ^{uninhabited} and rarely visited.

Gough is British and lies due south of Tristan da Cunha.

For Prince Edward Island an exclusive licence had been issued by the British authorities - see 1911 correspondence file 5/19.

I can find nothing about the ~~Heard~~ ^{Marion} Islands except that they were discovered by an American Captain of the same name, or about ~~the~~ Marion which is close to Prince Edward Island & may be one of same group. 25/7/19
