We had no loss of cattle this winter as the number increase abundantly I expect to see some lost by the next winter.

The days which we was able to landing on the Island not only passengers but also goods on January 24th February 23rd March 24th April 17th May 15th June 16th July 16th August 15th September 17th October 22nd November 20th December 30th. Total 238 days in the year 1909 able to land anything on the Island.

As I am instruct by the Rev.J.G.Barrow that on sending a annual report to H.M.the Government it would be much interest to your concerning the people and our welfare.

We are reach now the number of (100) and divide in 21 family all in good health.

(4) births as been during the year (3) male and (1) female, the one male belong to Mr Repetto a female to Andrew Twain this two are of the form family, a male belong to Joe Glass one of the three family which join us in the year 1908 from Cape Town and a male belong to Charly Green marry during the year. Marriage one.

The last marriage on the Island was officiate by me in the year 1905 as it was illegal marriage it was perform over again by the Rev.J.G.Barrow in the year 1908 when he was on the Island.

Charly Henry Green was married by me on the 12th of September 1909 which it will be a local marriage as I am appoint to officiate it by the Rev. J.G.Barrow when he left the Island on the 1st April by a Norwegian whaling steamer.

The number for the passing ships near the Island are (34) among the above number we were able to visit 19 which 15 were Britisher 2 Norwegian 1 American whaling and 1 French, though the number of vessel is larger than the last year but in the exchange of goods its very little difference between this year and the last year.

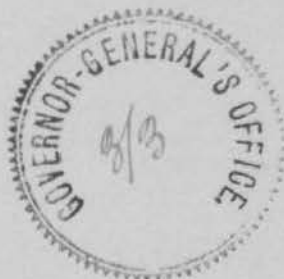
